Alpha Ionone Natural (CAS 127-41-3) is a single naturally derived aroma chemical belonging to the ionone family. It is widely used in perfumery to impart elegant violet, raspberry, woody, floral and orris-like notes.



Alpha Ionone is not included in the list of declarable cosmetic fragrance allergens under Annex III of Regulation (EC) No. 1223/2009, as amended by Commission Regulation (EU) 2023/1545. Accordingly, this material does not contribute any declarable EU cosmetic fragrance allergens.
