5. Regulatory Statement

Lime Oil 5 Fold is a concentrated folded essential oil obtained by cold pressing the peel of *Citrus aurantiifolia* followed by fractional distillation. The folding process concentrates the oxygenated aromatic constituents while reducing the terpene fraction, resulting in a more concentrated citrus aroma.



This material naturally contains Limonene, Citral, Linalool, Geraniol, and Citronellol, which are fragrance allergens listed under Annex III of Regulation (EC) No. 1223/2009 and Commission Regulation (EU) 2023/1545.

The declaration of these allergens on the finished cosmetic product depends on their concentration in the final formulation. Natural variation in allergen content may occur due to seasonal, geographical and botanical differences.

6. Statement of Conformity

Aromology certifies that, based on available supplier information, manufacturing data and compositional review, Lime Oil 5 Fold (*Citrus aurantiifolia*) has been assessed for the presence of fragrance allergens in accordance with:

- Regulation (EC) No. 1223/2009
- Commission Regulation (EU) 2023/1545

This declaration reflects the typical naturally occurring allergen profile of the material. The manufacturer of the finished cosmetic product remains responsible for determining whether allergen labelling is required based on the concentration of these constituents in the final cosmetic formulation.
