5. Regulatory Statement

Linalool Natural Ex-Basil is a natural aroma chemical isolated from Basil Essential Oil (*Ocimum basilicum*). The material consists predominantly of Linalool, which is a



declarable fragrance allergen under Annex III of Regulation (EC) No. 1223/2009 and Commission Regulation (EU) 2023/1545.

Minor traces of naturally occurring constituents such as Citral, Geraniol, Eugenol, and Limonene may be present depending on the botanical source and purification process. Natural variation may occur between harvests and production batches.

6. Statement of Conformity

Aromology certifies that, based on available supplier information, manufacturing data and compositional review, Linalool Natural Ex-Basil has been assessed for the presence of fragrance allergens in accordance with:

- Regulation (EC) No. 1223/2009
- Commission Regulation (EU) 2023/1545

This declaration reflects the typical allergen profile of the material. The manufacturer of the finished cosmetic product remains responsible for determining whether allergen labelling is required based on the concentration of these constituents in the finished cosmetic formulation.
