Declaration

Spearmint Essential Oil is obtained by steam distillation of the leaves of *Mentha spicata*. Based on supplier information, published compositional data and available analytical information, this material naturally contains fragrance constituents listed in Annex III of Regulation (EC) No. 1223/2009, as amended by Commission Regulation (EU) 2023/1545.

As a natural essential oil, the concentration of these constituents varies depending on geographical origin, climate, harvest season and distillation conditions.
