Spikenard Essential Oil is a natural essential oil obtained by steam distillation of the roots and rhizomes of *Nardostachys jatamansi*. Based on supplier information, published compositional data and available analytical information, this material may naturally contain fragrance constituents listed in Annex III of Regulation (EC) No. 1223/2009, as amended by Commission Regulation (EU) 2023/1545.

As a natural essential oil, the concentration of these constituents may vary depending on geographical origin, harvest season and distillation conditions.
