Strawberry Gum Oil is a natural essential oil obtained from the leaves of *Eucalyptus olida*. Based on supplier information, manufacturing knowledge and available analytical data, this material does not intentionally contain fragrance allergens listed in Annex III of Regulation (EC) No. 1223/2009, as amended by Commission Regulation (EU) 2023/1545, above the applicable declaration thresholds.
