This certificate confirms that Lemon Oil 5 Fold (*Citrus limon*) has been reviewed against the requirements of the International Fragrance Association (IFRA) Standards, 51st Amendment (June 2023).

Lemon Oil 5 Fold is a concentrated folded essential oil obtained by fractional distillation of cold-pressed lemon peel oil. The material naturally contains Limonene, Citral, Linalool, β -Pinene, α -Pinene and other naturally occurring terpenes, some of which are subject to IFRA Standards and cosmetic allergen declaration requirements.

The maximum recommended use levels shown below are based on the IFRA 51st Amendment and apply to the finished fragrance compound.
