2.3 Other hazards

The material contains 19.54% Beta-Caryophyllene. Beta-Caryophyllene and its oxidation products may cause skin sensitisation.

SECTION 4: FIRST-AID MEASURES

Inhalation: Move the affected person to fresh air. Keep at rest and obtain medical attention if symptoms persist.

Skin Contact: Remove contaminated clothing. Wash thoroughly with soap and water. Obtain medical advice if irritation or an allergic reaction develops.

Eye Contact: Rinse cautiously with clean water for at least 15 minutes. Remove contact lenses when easy to do. Obtain medical advice if irritation persists.

Ingestion: Immediately call a poison centre or doctor. Do not induce vomiting because of aspiration risk. Rinse the mouth.

SECTION 5: FIREFIGHTING MEASURES

Suitable Extinguishing Media:

- Carbon dioxide
- Dry chemical powder
- Alcohol-resistant foam
- Water fog

SECTION 6: ACCIDENTAL RELEASE MEASURES

Ensure adequate ventilation. Avoid breathing vapour and avoid contact with skin and eyes.

Prevent release into drains, groundwater, surface water and soil.

Contain with sand, earth, vermiculite or another inert absorbent. Transfer into a suitable labelled waste container.

SECTION 7: HANDLING AND STORAGE

Handle in a well-ventilated area. Avoid skin and eye contact. Wear suitable protective equipment.

Store in tightly closed and preferably full containers in a cool, dry and ventilated place.

Protect from:

- Direct sunlight
- Excessive heat
- Moisture
- Prolonged air exposure
- Ignition sources
- Strong acids
- Strong alkalis
- Oxidising agents

Recommended Storage Temperature: Below 25 °C.

SECTION 8: EXPOSURE CONTROLS/PERSONAL PROTECTION

Occupational Exposure Limits: None established for the complete natural material.

Eye Protection: Chemical safety glasses or goggles.

Hand Protection: Chemical-resistant nitrile gloves.

Skin Protection: Suitable protective clothing.

Respiratory Protection: Normally unnecessary with adequate ventilation. Use an appropriate organic-vapour respirator where ventilation is insufficient.
